Generally, a student must be admitted to an eligible program to be eligible for financial aid. However, there are two regulatory exceptions for Federal Direct Student Loans:

**State Required Teacher Licensure Coursework:** A student may receive federal student loans if enrolled at least half-time in courses required for Elementary or Secondary teacher's licensure, even if the student is not admitted to a degree program. Only course work which is required for licensure can be considered in determining eligibility and enrollment status. Any work outside the licensure requirements, such as, optional/elective courses, Certificate of Graduate Study, endorsements, traffic safety courses, etc., does not qualify. Institutions are required to review a student's registration to determine if courses are required for teacher licensure prior to disbursing federal aid.

**Courses required for admission to a program:** A student is eligible for Federal Direct Loans for up to one continuous 12-month period at the fifth-year undergraduate loan level if enrolled at least half-time in prerequisite coursework to be admitted into a graduate program or professional school. (Prerequisite coursework consists of required courses necessary for admission to a graduate program.)

**If eligible,** undergraduate Federal Direct Loan limits apply for teacher licensure and preparatory coursework.

Each semester, students must be enrolled in at least 6 hours of qualifying undergraduate/graduate coursework to be considered half-time.

*If a student is not pursuing an initial teacher's licensure or enrolled in prerequisite coursework, this form does not need to be completed. Another option is a private loan. For more information visit:*
