## **Enrollment History Appeal Requirements:**

Students who lose aid eligibility have the right to appeal to have their financial aid reinstated. Each appeal is decided on a case-by-case basis. The appeal must explain why you did not earn any academic credit at one or more of the institutions that you enrolled in during the last four academic years and what has changed to prevent you from not earning credit in the future. Include the name of the school(s) and the semester(s) in your explanation. Examples include, but are not limited to illness or injury, death of relative, lack of academic preparation and effort, and other circumstances that could not be anticipated, were beyond the student's control and presented hardship. Third party documentation should be attached whenever applicable.

### **Guidelines:**

- 1. Be specific when explaining your circumstances. Lack of information or documentation may result in a denial of your appeal. Address the questions "Why does my past academic history contain failing grades?" and "What has changed about my situation that will allow me to successfully pass courses?"
- 2. Provide supporting documentation.
- 3. Please print legibly, sign, and date your appeal form before submitting it to the Financial Aid and Scholarship Office.
