Direct PLUS Loans for Parents are federally guaranteed loans available to parents of <u>dependent</u> undergraduate students. An additional Direct Unsubsidized Student Loan may be available to a student whose parent has been denied the Direct PLUS Loan.

## **Parent PLUS Application Process**

- Student must complete the 2023-2024 Free Application for Federal Student Aid (FAFSA) and have received an award notification from NIU before this PLUS Loan application will be processed.
- Direct Loans (DL) will notify the borrower if they are approved or denied for the Direct PLUS Loan. If the loan is denied, DL will notify the borrower of the options to appeal the credit decision or use an endorser.
- Approved parent borrowers will need to complete a Master Promissory Note (MPN). It is recommended you complete
  the Parent PLUS MPN now at: <a href="https://studentaid.gov/">https://studentaid.gov/</a> The parent who completes this loan request is the parent
