Dissertation, "An Analysis of Mental Health and Absenteeism"

My dissertation develops a comprehensive theoretical model of health production and time allocation under the pretext of employment, so that an individual must consider contractual constraints as well when choosing optimal resource allocations. I use the theoretical framework as a basis to form empirical hypotheses regarding fringe benefits as moderators to the impact of mental health on labor supply in the form of absenteeism. I also address the issue of endogenous sample selection when focusing on the effect of mental illness on absenteeism among the employed. Empirical

analyses utilize data from the Medical Expenditure Panel Survey (MEPS) for years 2010 to 2014. Estimates of the effect of mental illness on absenteeism are consistently positive and significant, with men exhibiting higher degrees of additional absence in response to mental illness. Fringe benefits that promote a substitution of time spent on labor for time spent on health are consistent with the literature, and there is still persistent evidence that health insurance impacts absence rates through both the substitution of labor time for time spent utilizing healthcare services and through the channel of mitigating the impact that mental illness has on absenteeism.

"Moderate to Severe Diagnosed Mental Disorders and Absenteeism" (Job Market Paper)
This paper analyzes the effect of mental illness on absenteeism for employed adults utilizing data from the Medical Expenditure Panel Survey (MEPS) for years 2010 to 2014. Empirically, I estimate the effect of diagnosed mental illness on absenteeism while conditioning on heterogenous degrees of symptom severity and utilize a rich set control variables to account for many other sources of heterogeneity at the individual, family, regional, and macro-economic level. I also analyze how various job factors may either enhance or relieve some of the impact of mental illness on annual days absent from work. Results suggest that fringe benefits that encourage a substitution of labor time for time spent on health results in greater absenteeism; however, there is also evidence that this type of benefit acts as a mitigator to the magnitude of the impact of mental illness on absenteeism, supporting the hypothesis that benefit packages that promote worker wellness improve productive outcomes of employees. Additionally, results suggest that at moderate-to-severe levels of emotional distress, individuals with diagnosed mental illness exhibit better productive outcomes, which is a finding that supports the importance of early treatment and intervention in improving outcomes for those facing mental illness.
