NIU Employees can Request to be Removed from fall 2021 COVID-19 Surveillance Testing

Beginning Monday, Aug. 16, 2021, all employees will be added to the weekly surveillance testing pool. Employees can be exempt from testing if they have been fully vaccinated or if their supervisors and division leaders verify that those employees are working entirely remotely for the fall semester. To request to be removed from the testing requirement, please complete the form on the Protecting the Pack website by 11:59 p.m. CDT Thursday, Aug. 12.

You will need to provide which vaccine your received and the date of your final dose of the vaccine. You will also need to upload a clear photo or scan of your proof of vaccination (JPG or PDF file format). This will most likely be the CDC card issued to you when you received your first COVID-19 shot. If you did not receive a card, please upload a scan, screenshot or photo of any printouts or proof of vaccination that you received from the health provider where you received the vaccine.

Financial Aid and Satisfactory Academic Progress

What every student and staff member should know.

What is Satisfactory Academic Progress (SAP)?

Federal and state regulations require that students meet SAP to be eligible to receive financial aid, including student loans and federal campus work-study. There are three standards of SAP that are measured at the end of each semester to establish eligibility for aid for the next semester the student will attend. The standards reviewed are cumulative GPA, rate of completion (Pace) and maximum timeframe.

How and when is SAP evaluated?

SAP is evaluated at the end of each semester/payment period (including summer) for all students who enrolled for that semester/payment period regardless of whether the student applied for or received financial aid. The result of that evaluation determines a student's SAP status and financial aid eligibility for the immediately following semester/payment period that the student attends.

Reestablishing eligibility

A student who loses financial aid eligibility and has a SAP status of Not Meet **can attend**, if otherwise allowed by NIU Academic and Student Conduct policy, **without receiving financial aid**. Once the student meets all SAP standards, the student will reestablish eligibility and have a status of Meet for the next the semester the student attends.

A student may file an appeal based on special circumstances. If the student will be able to meet all SAP standards in one semester an academic plan is not required and students with an approved appeal will have a status of Probation.

If the student needs more than one semester to meet all SAP standards, an academic plan is required and student with an approved appeal will have a status of Plan.

Preparing an appeal

An appeal includes a personal statement, supporting documentation, and a meeting with your dean and/or academic advisor who will complete a course plan.

Summary

SAP regulations are established by the Department of Education (DOE), not by NIU, so they do not necessarily align with academic policy.

For example:

- A student could lose their financial aid eligibility, but not be dismissed from NIU. Once student meets all SAP standards, the student will reestablish eligibility and have a status of Meet for the next the semester the student attends.
- A student could get a GPA restart which would put them within the minimum GPA for academic policy, but they would still not be eligible for financial aid because they must have met the cumulative GPA standards for SAP.
- If a student decides to attend NIU and does not meet SAP and does not have an approved appeal, then they will be responsible for their charges and will not be able to receive financial aid until they are meeting SAP standards.
