# 2020 – present Winona State University, Provost, and Vice President for Academic Affairs

Winona State is a public university that serves 6,545 students with 5748 undergraduates at the Winona campus and 797 graduate students at Rochester. The Office of the Provost includes six colleges and eight administrative and service departments including Adult and Continuing Education (ACE), Grants and Sponsored Projects, Information Technology Services (ITS), Institutional Planning, Assessment and Research Services (IPAR), International Programs and Study Abroad, the Library, Outreach and Continuing Education. Certificates offered included one-year programs, Postbaccalaureate, Post-masters. Degrees include Associate's, Bachelor's, Master's, Doctoral of research/scholarship and Doctoral of professional practice.

- Academic Planning, Program Development, and Improvements in Faculty Development and Student Learning
  - In alignment with the academic plan, my office expanded pertinent online and hybrid programming with a clear identification of target audiences, modeling, and staffing. This included the establishment of measurable goals with Academic Affairs and the official declaration of a winter term online with support from Adult Continuing Education (ACE) and the Registrar's Office. Currently, my office is working with a faculty task force to offer general education classes online throughout the academic year.
  - To increase enrollment, my office initiated a Qualtrics survey with over two hundred companies offering tuition assistance to appeal to adult returners, non-traditional students, and those attending part-time, ideally offsetting an increase in student debt while providing accessibility to online classes.
  - Further development of an online learning program for adult returners and selected undergraduate students, in conjunction with the offices of Adult and Continuing Education and Graduate Studies. This support extends to Postsecondary Enrollment Options (PSEOs) As a goal, my office sought to measure and assess current and future students' needs and preferences to identify appropriate delivery methods and scheduling for academic programs and course offerings to be responsive to current and projected student demands. This effort also included a survey of Student Senators on the preferred teaching platforms for their constituents. Though data already suggested a preference for face-to-face offerings, the survey also determined that students would take online courses under specific conditions (i.e., completing GEPs, improving grades, taking prerequisites, and more).
  - Provided two campus communities with academic support to facilitate the growth and success
    of competitive online degree programs to compliment current undergraduate and graduate

catalogs. Encouraged undergraduate degree accomplishment for adult learners through partnerships with recruiters and corporate human resources that reward employees for completion. This included the support of continuing education on two-year pathway partnerships, joint admissions, corporate training, and potential corporate credit-based partnerships. Task forces studied the feasibility of more online offerings.

- Launched the development a strategic process to provide a comprehensive student experience for GEP and online degree pathway learners; furthermore, develop an innovative, ethical, and responsive method to incorporate current and emerging technology trends into the academic curriculum.
- Partnerships have strengthened through selected two-year colleges on certificate programming and "2 + 2" initiatives; primarily with Minnesota State College Southeast, the Rochester Community Technical College (RCTC), and Riverland college. Working in conjunction with admissions, I initiated our Guided Transfer Pathways planning as suggested by the MinnState System. This effort also includes the seamless acceptance of general education courses and working toward a common course numbering system among our four campuses through MOAs.
- Among other posts, I led the Deans' Council as provost, yet also served as interim graduate dean. Supervised and guided the group as they fulfilled their responsibilities to adapt innovative budgeting plans, and strategic planning in relation to their academic colleges, both in Winona and on the Rochester campus.
- To promote faculty scholarship, I led the revitalization of the Consortium of Liberal Arts and Science Promotion (CLASP) colloquia with the direct input of the Faculty Association, and library staff. With the support of the deans, I have encouraged multiple departments to consider these presentations during tenure and promotion through the support of our Inter-faculty Organization (IFO)
- Established working relationships with Student Senate's liaisons to Academic Affairs with emphases on student needs, and academic support; resulting in the initiation of multiple projects, including a Dean's Advisory Board for each of the five colleges, increased participation in Assessment Day and led in the organization of surveys that query preferred educational platform (online, face-to-face, hybrid, and hi-flex)
- Supervised and approved requests for faculty development and/or study abroad travel during COVID. Ongoing analyses and tracking of the Minnesota Department of Health (MDH) and the Centers for Disease Control and Prevention (CDC) guidelines were essential for faculty and student safety.
- Promoted and launched winter sessions courses online as regular offerings for the College of Business, and other schools.

- Coordinated Higher Learning Commission (HLC) accreditation visit for November 2021 at Winona State University which concluded successfully with a continuation of an Open Pathway and ten-year cycle; supervised the self-study for multiple criteria.

This effort included a study of academic program practices and policies to determine the impact on undergraduate and graduate enrollments, student retention, graduate rates, and student support services.
  - Continuing to establish and build relationships that lead to fundraising initiatives with our development officer and his staff. Ongoing discussions are taking place with two current presidents on the development of external stakeholder groups.
  - Worked closely with past development officers at multiple institutions to encourage donors and alums to attend colloquia, helping to support donations efforts as attendees learn more about current scholarship.

# 2017 – 2020 University of Wisconsin-Eau Claire, Associate Vice Chancellor of Academic Affairs and Dean of Graduate Studies

The University of Wisconsin Eau Claire is a public university that serves 10,569 students with 9,869 undergraduates. As Associate Vice Chancellor of Academic Affairs and Dean of Graduate Studies I oversaw the Academic Skills Center, the Center for Writing Excellence, Center for Excellence in Teaching and Learning (CETL), the Honors Program, Intercultural Immersions, and the International Education and Study Abroad program. As Dean of Graduate Studies, I was responsible for the direct supervision of eight college deans and one assistant. Certificates offered included less than one-year programs, Postbaccalaureate, and Post-master's degrees. Degrees include Associate's, Bachelor's, Master's, Doctor's-professional practice and Doctoral of professional practice.

- o Academic Planning, Program Development, and Improvements in Faculty Development and Student Learning
  - With a grant from the National Association of System Heads (NASH) Taking Student Success to Scale (TS3) project, I co-directed a team to build equitable access to high-impact practices (HIPs) for students from traditionally under-represented groups. The project determined the barriers that prevent students of color from participating in study abroad/immersion, student-faculty research, and internships. An assessment plan focused on evaluating equity in learning outcomes, as well. With the approval of the Institutional Review Board (IRB), the team

gathered participation data through student focus groups to understand their experiences.

- Leader of the Institutional Change Team (ICT) for the UW System Math Initiative in which I
  worked with the Chair of Mathematics, and campus representatives from 14 UW institutions on
  the revision of statewide enrollment rates in math courses, a reduction of students needing
  remedial math, and the streamlining the transfer of credit-bearing gateway math courses.
- Managed the undergraduate directors of the Academic Skills Center, the Center for International Education, Intercultural Immersions, the Center for Writing Excellence, First Year Experience, and the Honors programs. The school included twelve academic departments that supported also supported three graduate programs. Among other responsibilities, I served as coordinator of the interdisciplinary major program including oversight and curriculum development.

  - The organization of colloquia for the school and encouragement of junior faculty from across the disciplines to give presentations as part of their service and professional development, including co-presentations that open these proceedings to faculty from outside our college. I have also brought in faculty from various institutions to present, as well as media professionals such as actor/director Tim Reid.
  - When considering other university-wide projects, I donated a series of BBC audiotapes of archival radio programming to the library for students and faculty to use. I made sure to share this with the Chairs so that faculty could encourage students, particularly those in the humanities, to access these tapes for educational purposes.
  - I collaborated with marketing to develop a new website for the college, including supervision of updated information about majors and programs, the incorporation of specific social media applications, upcoming events, and more. I also worked closely with marketing to roll out a

promotional campaign touting the value of a liberal arts education.
