I. Call to Order:

President Doederlein called the meeting to order at 10:00 a.m. Approval of Agenda motioned and seconded. No objections/abstentions, all in favor, motion passes, Agenda approved. (Movant: Bernoudy; Second: Stoker)

II. Guest Speakers: President Lisa Freeman

Freeman's message was about moving from our FY21 goals of empowerment and shared representation, to managing changes post pandemic. Freeman asked SPS employees:

What kind of professional development around "change management" will be the most helpful?

She asked employees to think about what has been learned from COVID, what needs to be preserved, and what can be done to make things easier going forward?

Dr. Freeman praised the SPSC's 2017 Survey suggesting it could be expanded campus-wide. She asked SPS employees to engage with NIU leadership in managing NIU's future. Dr. Freeman also spoke about a recent retreat about creating an anti-racist campus. Senior leadership wants the councils to be engaged with them—to be thinking about defining/recognizing barriers and how to remove them.

Dr. Vernese Edghill-Walden, VP for Diversity, Equity and Inclusion; Chief Diversity Officer

Re: professional evaluations, Walden asked what is in a professional evaluation to monitor success in diversity and inclusion. She asked to hear from SPS and OSC employees about what success would look like to them on this question.

Dr. Edghill-Walden reported that HR is updating their technology and suggested we check out the HR website. There was also a brief discussion about COVID and the processes the University is following, also on the website. (Liz Guess discussion of COVID procedures)

Professor Matt Streb reported that spring is going to look very much like this fall. He reminded everyone it is very important to get a flu shot. He also reported there are no plans for additional layoffs this calendar year. **Pulchratia Smith** discussed how layoffs are determined and answered questions about the process and explained how bumping works.
