B. College of Health and Human Sciences

1. Michael Kushnick, Associate Dean, was introduced to present the items in V.B.1. of the agenda. Ghrayeb called for a motion to discuss and vote on section V.B.1. College of Health and Human Sciences items. Caughron so moved and this was seconded by McCarthy.

Kushnick discussed the need for an alternative way to maintain current information on the clinical requirement for students in the Health and Human Sciences programs. Catalog updates are slow and this often leads to inaccurate information contained in the programs for the clinical requirements. To eliminate this issue, CHHS has developed a clinical website that is easily updated and the link is provided in the catalog language. Kushnick fielded questions about how the clinical requirements are different from the program requirements. Clinical requirements are needs that must be meet with partner institutions prior to NIU students being placed to do clinical requirements. While these clinical requirements are needed to fulfill program requirements the contractual requirements change frequently and need to be updated in a timely fashion. The example of updating vaccines required was used to illustrate an example of how the clinical requirements change rapidly, due to evolving health risks, within clinical settings.

The vote was called and Section V.B.1 was **APPROVED unanimously.**
