- I. ADOPTION OF AGENDA Ghrayeb called for a motion to approve the agenda for November 12, 2020. Caughron so moved and this was seconded by Gorman with a request to move items VII.A-E after III. Caughron amended his motion and the agenda was APPROVE unanimously for the November 12, 2020 BACCALAUREATE COUNCIL MEETING.
- **II. APPROVAL OF MINUTES** The minutes for the 10.08.2020 meeting of the Baccalaureate Council were approved via electronic vote. They have been distributed to the Faculty Senate and Teams for general access.

III. ANNOUNCEMENTS

- A. Cecilia Hernandez is the student representative from the College of Liberal Arts and Sciences for the academic year 2020-2021.
- B. Amanda Durik will sit for the remaining fall 2020 meeting for Steve Daskal for the College of Liberal Arts and Sciences. Daskal has a teaching conflict but will sit for spring 2021.
- C. David Gorman was nominated by Caughron to replace Amanda Ferguson as the Assistant Chair of the Baccalaureate Council for spring 2021. Gorman's nomination was approved by acclamation. Ferguson will be on sabbatical in spring 2021.
- D. Christine Mooney will sit for spring 2021 for Amanda Ferguson for the College of Business.
- E. The electronic voting for the Baccalaureate Council will now utilize the voting button feature in Microsoft outlook.

IV. NEW BUSINESS

A. Andrea Radasanu presented the proposal to change the requirements for Honors Transfer Credit. Ghrayeb called for a motion to discuss and vote on the proposal.

Caughron so moved and this was seconded by Ferguson. The purpose of the proposal is as follows:

- To allow those pursuing Associate University Honors (AUH) to count a maximum of three points toward program completion. Currently, unlike those pursuing Full University Honors (FUH), they are not allowed to transfer any honors credits.
- To specify the number of points allowed to count for transfer students pursuing FUH. Current catalog language does not impose a maximum on Honors courses that can be transferred for FUH, nor does it stipulate that capstones and Honors seminars should be completed at NIU.
- To allow co-curricular activities to count towards NIU UHP points. Currently, it is not possible to transfer credit for co-curricular points.

The proposal was **APPROVED unanimously**.

B. Steve Estes presented the proposal to expand and clarify the Foundational Studies Quantitative Literacy language to include IAI non-equivalents. Ghrayeb called for a motion to discuss and vote on the proposal. Caughron so moved and this was seconded by Devroye. The language clarification at issue is (for complete language please see Section D):

This requirement can be satisfied by:

• passing MATH 101 or equivalent course (including Illinois Articulation Initiative Foundational Studies Quantitative Literacy courses that do not have a direct NIU course equivalent), or

The proposal was APPROVED unanimously

C. Steve Estes presented the proposal to re-envision Academic Recovery via GPA reset. Ghrayeb called for a motion to discuss and vote on the proposal. Myles so moved and this was seconded by Caughron. This proposal creates a one-time option for recalculation of GPA under the new academic recovery policy. This proposal shortens the ten-year rule to two years and eliminates the 60/80 rule.

The proposal was APPROVED unanimously

D. Margee Myles presented the proposal to delete the course withdraw limits from the undergraduate catalog. Ghrayeb called for a motion to discuss and vote on the proposal. Caughron so moved and this was seconded by Ferguson.

E. Halverson presented the Change of Grade catalog language. Ghrayeb called for a motion to discuss and vote on the proposal. Caughron so moved and this was seconded by Myles.
