The B.S. in Applied Management (with an emphasis in either Instructional Technology, Training and Evaluation or Equity Leadership and Mentoring) degree completion program is designed to award credit to practicing professionals for their recent education and previous learning experiences in the area relevant to the proficiency credit being requested. NNGO 492 is a writing infused course

Rationale: Grants are common both in the public and the nonprofit sectors and cut across several different sub-sectors such as education, health and human services, and arts and culture. They are a significant portion of revenue for many nonprofit organizations, particularly those that are dependent on government funding and foundations. To be successful at grants, an organization needs to understand the landscape of the nonprofit sector, the various types of nonprofit revenue, data and program evaluation, and be able to understand financial terms and construct a program budget. Successful grant proposals have a strong case for support with a realistic budget and clear metrics of program success. There is high demand for these skills across many disciplines.

We propose a 12 -credit certificate which will include three existing courses that are offered on a regular basis. The three courses are English 350 Technical Writing, NNGO 301x Philanthropy and Fundraising, NNGO 352 Nonprofit Program Development and Evaluation. ENGL 350 is the only course that has prerequisites that are not part of the certificate, so the certificate will be attractive to majors across the university. A new course, a grant writing seminar which we propose at the 400 and 500 level to also be of interest to graduate students across the university. This course will not have any pre-requisites as well. There is one undergraduate course at NIU that includes grant proposal writing (PHHE 439 Funding for Programs in Public Health) but is specific to public health. The new NNGO course would be broader to include all different kinds of grants to address a broad range of issues. The certificate is meant to enhance any student's knowledge about grants and demonstrate grant proposal development proficiency in the job market in order to enhance student career marketability.

Impact Statement: The Department of English has been consulted regarding the addition of ENGL 350 to the list of requirements. They did not identify any negative impact on course availability, enrollment, or teaching loads with this addition. See impact statement from PHHE 439 in Teams.

Rationale: 1) The revised title proceeds from recent changes in the degree whereby the College of Education's BSAM track was removed from the BSAM degree and made its own major in the College of Education. This permits the College of Liberal Arts and Sciences, and the School of Public \& Global Affairs, to rename the degree to more accurately characterize the degree by a simpler title: The BS in Public Service. 2) The language makes it clear that the degree is designed as an online degree completion program for students early in a public service career track, primarily police, fire, and public works positions. 3) The revisions eliminate the idea of a BSAM specialization and create a simple major structure with a relatively clear pathway to degree completion.

Together, these changes will make it easier to attract nontraditional students in public service career paths to NIU courses. It also creates a career pathway to the Master of Public Administration as the students mature and desire to rise in management ranks within their public service organizations. We are already working with Elgin Community College on a streamlined articulation agreement to create pipelines of police and fire students into the BS(AM)-PS degree.

Impact Statement: The Departments of Communication Studies and Economics were consulted regarding the addition of their courses to this program. Neither department identified any negative impact on course availability, enrollment, or teaching loads with these changes.
