The recommendation to align each Domain with three student learning Outcomes (SLO) is as follows:

Creativity and Critical Analysis:

- 1. Quantitative and Qualitative Reasoning
- 2. Critical Thinking
- 3. Intercultural Competencies

Nature and Technology:

- 1. Global Interconnections/interdependencies
- 2. Critical Thinking
- 3. Human Life and Natural World

Society and Culture:

- 1. Global Interconnections/interdependencies
- 2. Critical Thinking
- 3. Intercultural Competencies

Foundational Studies- assessed by 1) Written Communication/Critical Thinking, 2) Oral Communication, 3) Collaboration, 4) Quantitative & Qualitative Reasoning

The full General Education Committee concurred that aligning a subset of the SLOs with the Knowledge Domain and Foundational Studies framework was a good way to restructure the program. Both allowing for a better method to assess which courses fit into which domains and as a solid assessment foundation for the program as a whole.

Ghrayeb will work with additional Councils and Committees to obtain feedback with the assistance of Subramony and the Assessment Sub-Committee members. The Provost, Council of Deans, Curricular Deans, and Baccalaureate Council will be asked for feedback and sign off on the proposed realignment and assessment strategy.
