- Too many outcomes and some of them aren't measurable
- Curriculum map lots of master levels programs; less beginner's programs and more proficient level courses should be there only 6 of 15 were proficient
- On the rubrics fix "N" and "S"
- Remove the "introduction" wording that is on both the assessment plan and the status report
