## NIU BYLAWS ARTICLE 14: UNIVERSITY FACULTY SENATE

#### 14.5 Officers

- **14.5.1** The executive secretary of the University Council shall be elected by the voting members of the University Council from the elected faculty members of the University Council in accordance with Section 3.2 of the University Constitution and Section 1.3 of these Bylaws. The Executive Secretary of the Council shall also serve as President of the Faculty Senate. The Senate shall elect such other officers it may consider essential for the performance of its duties.
  - **14.5.1.1** The initial selection of candidates for the office of Executive Secretary of the University Council shall take place at the second spring semester meeting of the Faculty Senate. Any faculty senator may suggest or second the suggestion of a candidate. To be qualified to serve, the candidate must be an elected faculty member of the University Council for the current and for the ensuing year.
  - **14.5.1.2** Suggested candidates for the office of Executive Secretary shall submit a letter of intent to be included with the agenda for the third and fourth (last) spring semester regularly scheduled meetings of the Faculty Senate.
  - **14.5.1.3** An election of the final candidate for nomination shall be conducted by secret ballot at the last regularly scheduled meeting of the normal academic year of the Faculty Senate. All Faculty Senators present may cast a ballot for the candidate. If there are more than two suggested candidates, the final nominee must receive a majority of the votes cast. If no candidate receives a majority, subsequent ballots will be taken removing the candidate receiving the fewest votes until a candidate is selected.
  - **14.5.1.4** The voting members of the University Council will vote by secret ballot to accept or reject the nominee at the last University Council meeting of the spring semester.
- **14.5.2** The election of a vice president shall take place at the first Faculty Senate meeting of the academic year.
- **14.5.3** The term of office for all officers shall begin August 16 and shall be for one year. An officer may serve successive terms.

Dear Colleagues,

I appreciate and am I humbled at the confidence and respect that such a nomination entails. We have, as a faculty, many important challenges ahead of us. We must ensure that the University is placed in a solid position for growth and we must be a voice for openness and inclusion. We faculty can highlight the importance of the students, staff, and faculty, unlike any other group. We are the institutional memory and the conscience of the University and we have a powerful voice.

I would like to introduce myself in a more formal way. I am an Associate Professor of Electrical Engineering and have served as the Associate Director of the Microelectronic Research and Development Laboratory for the last 15 years. I am a second generation academic, my father is a Professor of Mechanical Engineering at UT Arlington. I grew up in Arlington and received all of my degrees from UT Arlington. I came to NIU 16 years ago, after a fairly successful career in industry, to contribute to the next generation of engineering students. I mentored several NIU graduates when I was at Honeywell and was impressed with the quality of the engineers coming from such a small program. When I arrived here, I felt so strongly that the University is a community that my family and I became apart of the DeKalb community.

As a member of Faculty at NIU, I have served in various committees at the department level and the college level. Most significantly, I was the Chair of the Departmental Personnel Committee from 2009 to 2017. I stepped down to go through the promotion process. Since 2014, I have been a member of both the Faculty Senate and later the University Council.

I would like to share with you my vision for the Faculty Senate and University Council:

Increase transparency. I would like to encourage all faculty, students, and staff to
attend meetings and bring up concerns to both the Faculty Senate and University
Council committees and sub-committees. In my conversations with other faculty
and students, there is very little awareness of the existence and the power of such
open forums and public bodies.

- Increase outreach. Convince faculty across the campus that it is important for them to give up some of their precious time to participate in the Faculty Senate. I know that many departments have problems getting professors to participate.
- Continue Linda Saborio's progress in the following:
  - Continue the hard work put forth by Greg Long, Therese Arado, and the members of the Rules, Governance and Elections Committee in creating an easily accessible policy library
  - Push for transparency in regard to the budget, program prioritization, enrollment management, and more
  - · Review and protect academic procedures and policies as deemed necessary
  - Maintain open communication with the recently established faculty union to ensure faculty needs are heard and met
- Reduce and consolidate the committees in both the Faculty Senate and the University Council to reduce the burden on serving members. This reduces the administrative burden on the Faculty.
- Fully implement the Open Meetings Act. The act is an outline of how the state and local governments shall abide by the first amendment of the constitution "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances."

**Rationale:** The purpose of this amendment proposal is to allow **one month** between the date on which the list of eligible faculty to serve as Faculty Senate President is made available to the Faculty Senate members and the date on which nominations are taken.

- The current bylaw language requires that the list of eligible faculty be "walked in" to the Faculty Senate meeting on the same day that nominees are taken, allowing approximately 30 minutes or less for discussion among faculty members. The proposed language changes the time line to one month.
- Candidates' letters of intent will be included with the agenda for the fourth meeting in spring semester.
- Elections will continue to be held at the last regularly scheduled meeting (no proposed change).

## ARTICLE 2: OFFICERS OF THE FACULTY SENATE

- **2.1** The Executive Secretary of the University Council shall also serve as President of the Faculty Senate. The Executive Secretary is nominated by the Faculty Senate from the elected faculty members of the University Council and is elected by the University Council.
  - **2.1.1** The initial selection of candidates for the office of Executive Secretary of the University Council shall take place at the second third spring semester meeting of the Faculty Senate. Any faculty senator may suggest or second the suggestion of a candidate. To be qualified to serve, the candidate must be an elected faculty member of the University Council for the current year and for the ensuing year.
  - **2.1.2** Suggested candidates for the office of Executive Secretary shall submit a letter of intent to be included with the agenda for the third and fourth (last) spring semester regularly scheduled meetings of the Faculty Senate.
  - **2.1.3** An election of the final candidate for nomination shall be conducted by secret ballot at the last regularly scheduled meeting of the normal academic year of the Faculty Senate. All faculty senators present may cast a ballot for the candidate. If there are more than two suggested candidates, the final nominee must receive a majority of the votes cast. If no candidate receives a majority, subsequent ballots will be taken removing the candidate receiving the fewest votes until a candidate is selected.

#### RESOLUTION IN SUPPORT OF MARCH FOR OUR LIVES

# NIU Faculty Senate April 25, 2018

WHEREAS, on April 20, 1999, two gunmen opened fire in Columbine High School in Columbine, Colorado, killing 13 people, including students and faculty;

WHEREAS on April 16, 2007, a gunman opened fire in Virginia Polytechnic Institute and State University in Blacksburg, Virginia, killing 32 people, including students and faculty;

WHEREAS, on February 14, 2008, a gunman opened fire in Cole Hall at Northern Illinois University in DeKalb, Illinois, killing five students;

WHEREAS, on December 14, 2012, a gunman opened fire in Sandy Hook Elementary School in Newtown, Connecticut, killing 20 children between six and seven years, and six faculty;

WHEREAS, on February 14, 2018, a gunman opened fire in Marjory Stoneman Douglas High School in Parkland, Florida, killing 17 people, including students and faculty;

WHEREAS, as recently as March 20, 2018, a gunman opened fire in Great Mills High School in Lexington Park, Maryland, shooting two students and killing one of those students;

WHEREAS, these acts of violence have caused students to feel unsafe in their educational institutions and have caused increased stigma against mental health awareness;

WHEREAS, there are issues both within the gun control laws of the nation and within the mental health care system that must be addressed to ensure the safety and well-being of our students and our young people;

WHEREAS, the second amendment to the U.S. Constitution gives the right to bear arms, and this amendment should be upheld, but there should be "common sense" gun reform that protects the safety of both the user and the community around them;

WHEREAS, these mass shootings have also sparked a debate about the mental health care system in the United States;

WHEREAS, efforts should be made to provide those who are struggling with emotional distress or mental health issues with proper medical care and resources;

WHEREAS, efforts to address the issues surrounding gun control and mental health within our nation have been met with both positive and negative reactions from the media and politicians;

WHEREAS, on March 14, 2018, students all across the country from higher education institutions, high schools and grade schools walked out of class as part of the March For Our Lives movement to protest legislative inaction surrounding these mass shootings;

WHEREAS, negative comments include ones such as those from Leslie Gibson, a candidate for the Maine State House called Emma Gonzalez, a Marjory Stoneman Douglas survivor and an organizer of the March For Our Lives movement, a "skinhead lesbian;"

WHEREAS, other comments from politicians and certain media outlets have labeled the movement as "run by children" and that their opinions are therefore invalid;

WHEREAS, these negative comments have been countered with messages of support from all across the country, including institutions of higher learning such as Northern Illinois University;

WHEREAS, on February 27, 2018, NIU released a statement that affirms "an individual's right to freedom of expression...we want to reassure students who have been admitted to NIU or are awaiting notification from us, that if peacefully and responsibly participating in protests against gun violence prompts discipline from your high school, that disciplinary action will not jeopardize your admission to NIU;"

WHEREAS, additionally a large number of NIU students are from Chicagoland area, which is deadly in terms of gun violence and pose legitimate safety concerns for those who have lived in or have family in those areas;

WHEREAS, these issues of gun control and mental health are ones that are prevalent within the Northern Illinois University community, especially because of our own personal experience with the 2008 mass shooting that happened on our campus.

**THEREFORE BE IT RESOLVED** that the members of the Northern Illinois University Faculty Senate fully support the students behind March For Our Lives and other related causes and urge our legislators to take comprehensive action to address these issues.
