A review of the September 1 draft FS agenda included the following points:

- A consent agenda will be presented for approval, including approval of: FS standing committee membership rosters, University Advisory Committee to the Board of Trustees membership roster, Ferald Bryan to serve as FS parliamentarian, faculty

candidates running unopposed to serve on committees of the university, Peter Chomentowski to serve as NIU's academic representative to the State Universities Retirement System Members Advisory Committee.

- A proposed amendment to FS Bylaws, Article 1, will be brought forward for a second reading and vote. The proposal intends to change the term length of Operating Staff representatives to Faculty Senate from three years to one year.
- A proposed amendment to FS Bylaws, Article 2.1.3 will be brought forward for a first reading. The proposal intends to remove the term, "secret," from the existing balloting language in order to comply with the spirit of the Illinois Open Meetings Act.
- A proposed amendment to FS Bylaws, Article 4.3 will be brought forward for a first reading. The proposal intends to remove the position of vice provost for institutional effectiveness from the membership roster since that position no longer exists.
- Reports are anticipated from NIU's representative to the Faculty Advisory Council to the IBHE, University Advisory Committee to the Board of Trustees, FS/UC Rules, Governance and Elections Committee, Social Justice Committee, Student Government Association, Operating Staff Council, Supportive Professional Staff Council.
- **S. Marsh** moved to approve the September 1 draft FS agenda per above discussion, seconded by **I. Montana.**
